

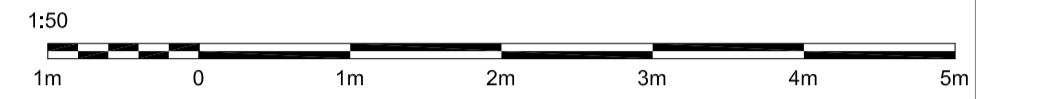

HEALTH AND SAFETY / CDM

- Principal contractor is responsible for ensuring all works activities on site can / are undertaken safely with specific Risk assessments and Method statements for each stage of works prior to any works commencing.
- Principal contractor should review in detail all design stage DRAs and look for practical construction methods to reduce further any residual risks, liaising with the Principal designer.
- Contractor to ensure all operatives are competent, suitably trained and supplied with suitable PPE, if required which is in good working order, for each specific task. PPE should only be used if principal contractor can not design it out.

DEMOLITION

Demolition to be undertaken by competent contractor with suitably trained operatives only.

Measures to protect the public to be agree and in place prior to commencement of any works.

A compound hoarding to be supplied and installed by demolition contractor and responsibility for any damage to the hoarding to be repaired by them during the demolition works.
