



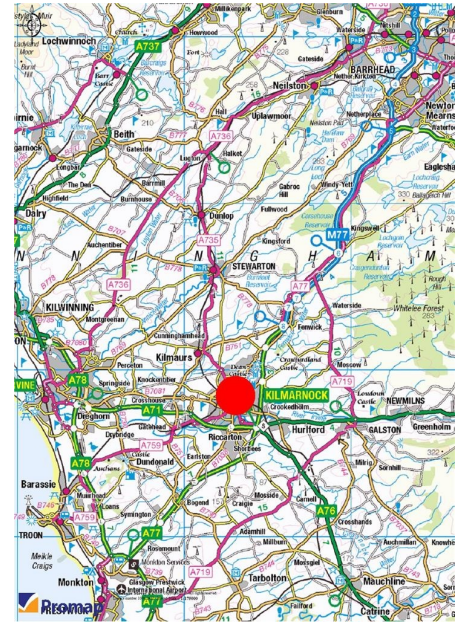

## LOCATION

Kilmarnock is situated within East Ayrshire and has a resident population of approximately 46,159 persons (Census 2011). The town is situated approximately 7 miles east of Irvine, 13 miles north east of Ayr, and 25 miles south west of Glasgow, connected by the A71 and A77/M77 trunk routes respectively. The A77 and M77 provides direct access to Glasgow and the Scottish motorway network.

Moorfield North Industrial Park is situated on the west side of Kilmarnock, fronting the A71 Kilmarnock to Irvine road and comprises a master-planned, fully serviced industrial park split into Phase 1 and Phase 2. Phase 1 was marketed by Graham + Sibbald and is currently under offer, with Phase 2 being promoted by East Ayrshire Council for industrial use.

The surrounding properties in the estate are generally commercial/industrial occupiers, including GAP, MKM Building Supplies, Braehead Foods, PDM and Burns Pet Nutrition.
