LOCATION

Kirriemuir, which has an approximate population of 7,000 is located within the heart of Angus, approximately 18 miles north of Dundee and 6 miles west of Forfar off the A90 Edinburgh/Aberdeen dual carriageway. The town is a popular residential location and provides all amenities associated with a settlement of his size, while further retailing opportunities are located within Forfar, which is the administrative headquarters for Angus Council.

The subjects are located to the north of Kirriemuir town center via whiteside. Surrounding buildings are all residential.

DESCRIPTION

The subjects comprise a part single, two and three story detached former social work office building. Internally the accommodation offers cellular type configuration throughout.
