The property is situated on Wilfred Place, off Queens Road in the Hartshill area of Stoke on Trent. Queens Road is accessible from Hartshill Road (A52) which connects Stoke town centre (0.75 miles distant) with Newcastle under Lyme town centre (1.0 mile distant).

Hartshill is a predominately residential area with a wide range of local amenities close to the Royal Stoke University Hospital (0.5 miles distant) and Stoke on Trent train station (1.0 mile distant).

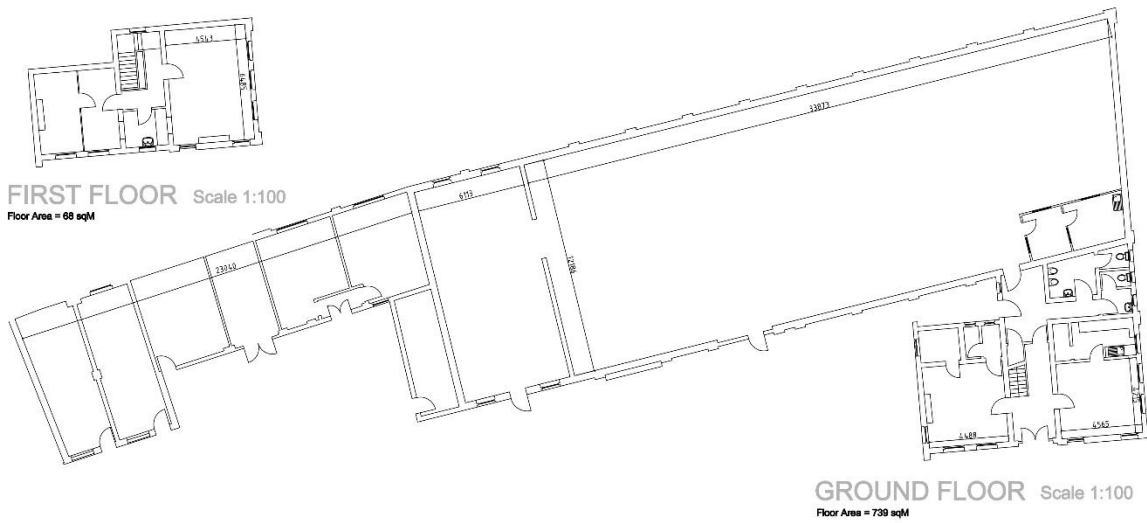
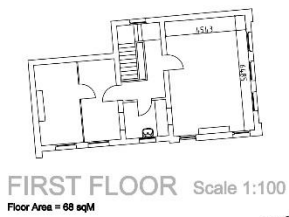
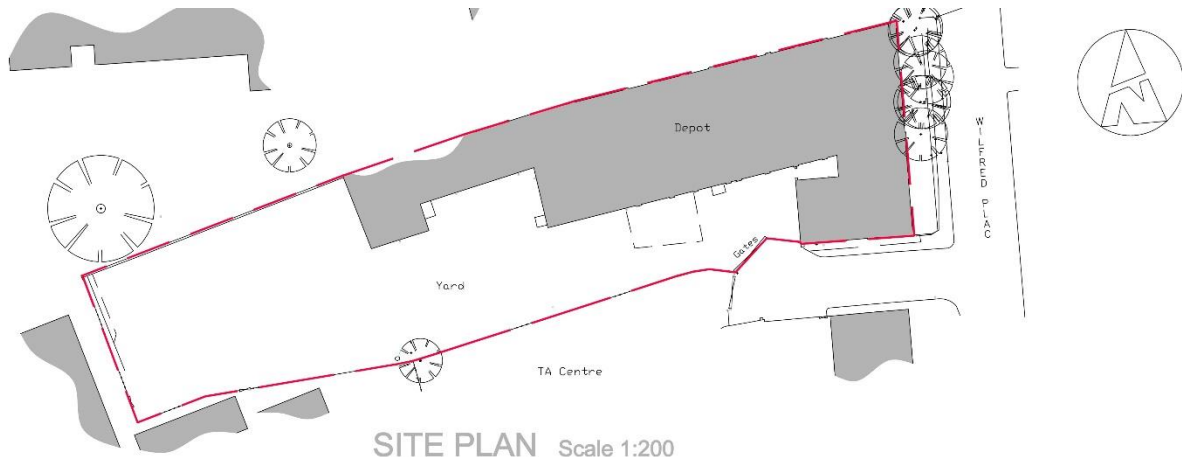
