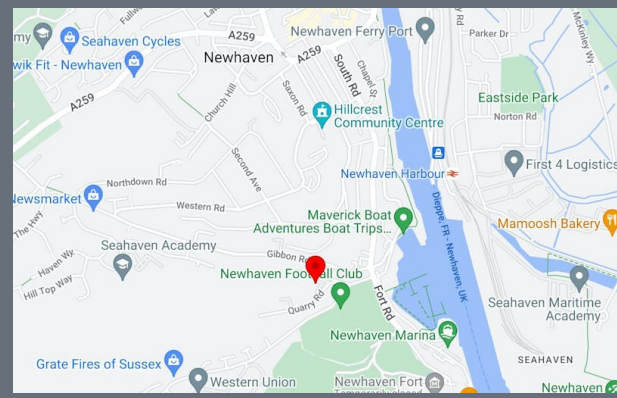
Warehouse units situated on The Quarry Road Industrial Estate. Some of the units benefit from electric loading doors, 3 phase electric, water supply & car parking spaces.
