



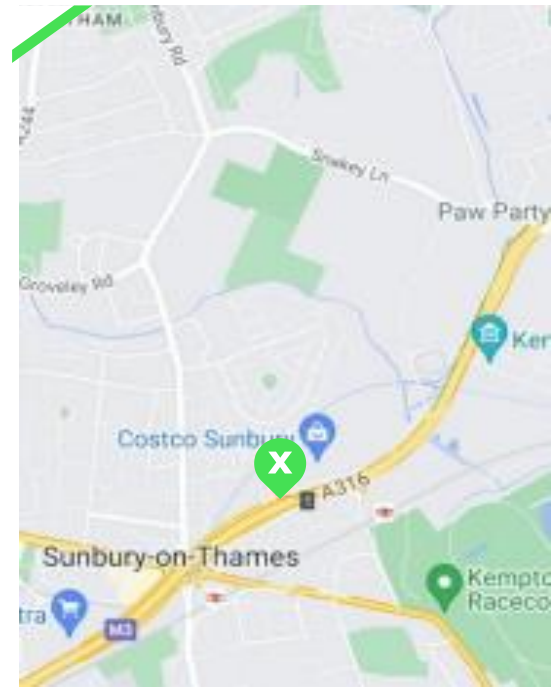

LOCATION

The premises are situated on Hanworth Road, which runs parallel to the slip road off the A316 / Junction 1 of the M3 (northbound). The unit is located adjacent to Jaguar Land Rover, Attic Self Storage and Costco. Sunbury on Thames train station and shopping centre is within 0.5 miles. Local amenities include a Marks & Spencer Food hall, Tesco & Costa.

The property is situated 2.4 miles south of Feltham and 5 miles south of Heathrow Airport. The M3 provides access to M25 at J12 and London via A316, 8 miles to the south west. The M3 provides a direct link to the south coast ports of Southampton and Portsmouth.

South West Trains operate a frequent rail service to London Waterloo with a journey time of 40 minutes.
