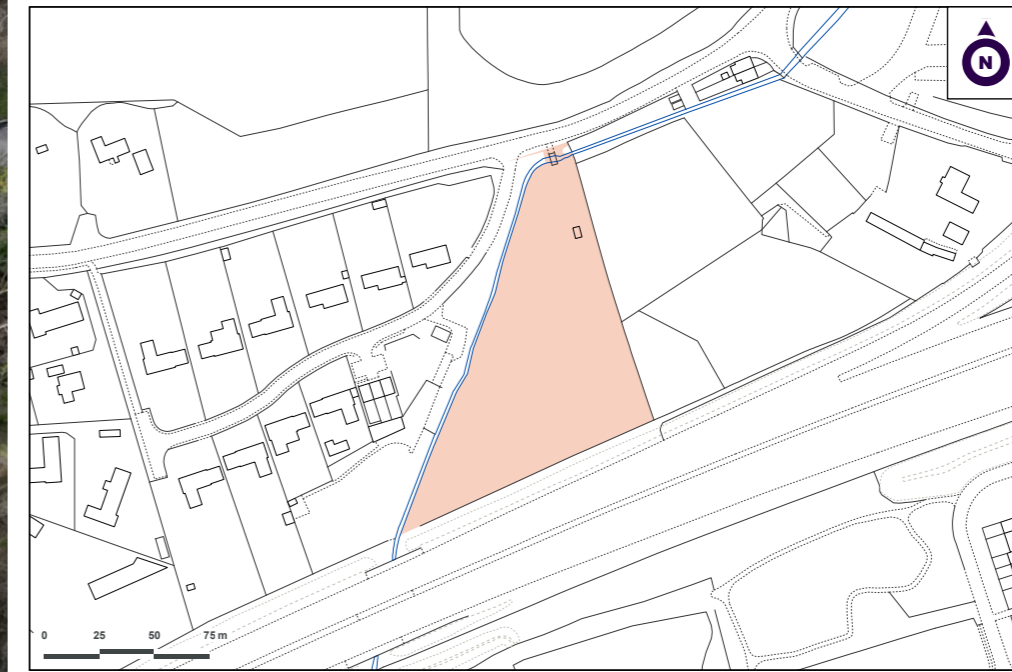

Property

The site offers direct access off Windmill Hill road with ample space for open storage or equestrian use. The land is currently laid to grass, with mature hedgerows surrounding all sides of the block. A timber field shelter is situated towards the centre of the field parcel.

There is a drainage ditch running along the north-western boundary of the Property, extending beneath the gated entranceway off the adopted highway.

Location

Junction 37 (A14) is located approximately 400 yards from the Property.

The land is situated immediately east of the village of Exning, approximately 1 mile from the village centre.

Access

The Property is currently accessed directly off Windmill Hill Road. Secondary access can be achieved via Shepherd Close.

Services

No mains services are currently connected.

Outgoings

The incoming Tenant will be responsible for all outgoing including any taxes associated with the letting.
