Each floor benefits from its own kitchen and WCs. There are a number of partitioned meetings rooms / offices that can be removed depending on occupier requirements. There are 20 allocated parking spaces.

The building is prominently positioned on the corner of Bricket Road and Victoria Street, within a short walk of both the city centre shops and St Albans Thameslink railway station.

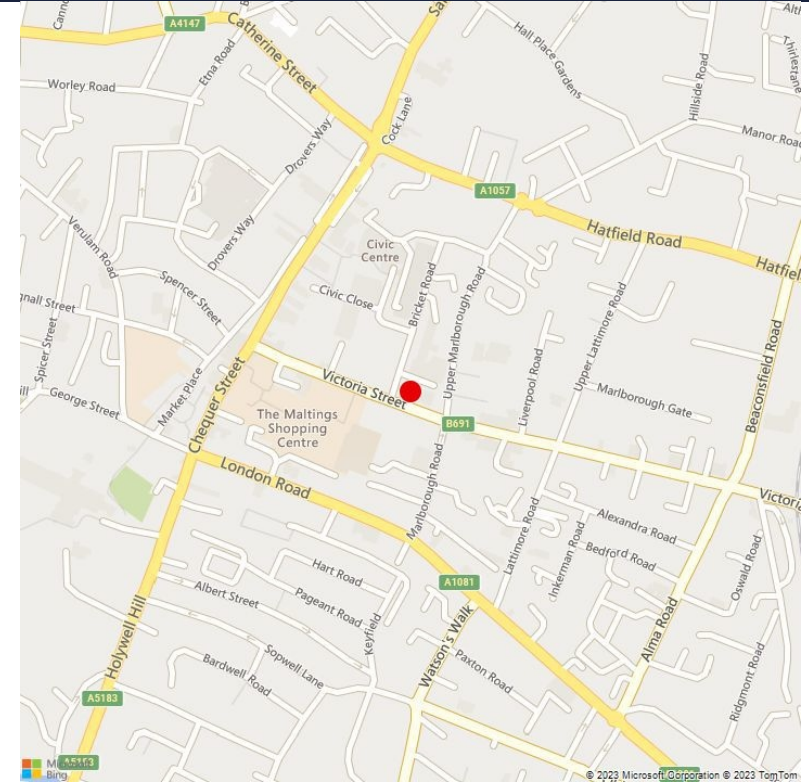
