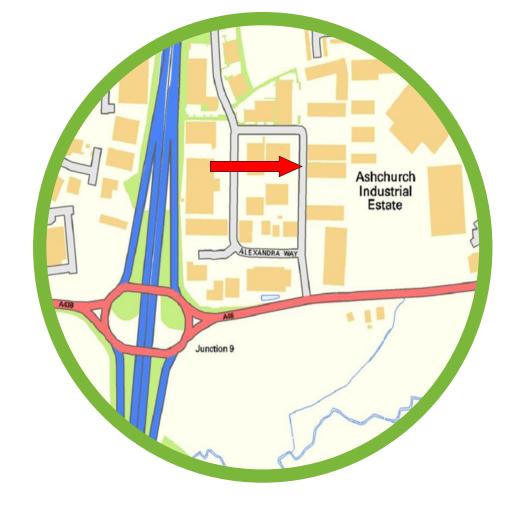


Location
