Welwyn Garden City is located approximately 25 miles north of central London, 6 miles from J23 of the M25. The A1 (M) is less than 3 miles drive from the building, whilst the A414 runs to the east of the town and offers access to the A10 and M11.

Welwyn Garden City mainline station is within walking distance of the property and offers a direct service in to London Kings Cross in less than 30 minutes.
