Description

The property comprises a new neighbourhood retail development situated in the Taylor Wimpey's substantial Limes Park Housing Estate. The subject unit is one of four retail units, with free customer car parking in front.

The premises are of a shell condition, and benefit from a fully glazed aluminium framed shop front and rear loading. Capped services (gas, water, electric) are located within the unit. Gas is located outside the premises behind in rear service yard

Location

The property is situated to the north of Basingstoke and a short distance from both the A339 Ringway North and the A340 Aldermaston Road, behind the North Hampshire Hospital. Junction 6 of the M3 motorway is only 3.5 miles drive to the south and Junction 11 of the M4 motorway is approximately 15 miles to the north. Operators within the centre are Southern Co-op, Subway and Costa Coffee.
